




# Navigating through Uganda's Oil & Gas sector: The Atacama Consulting Story

#### Getting involved in the oil and gas sector

Atacama's involvement in Uganda's oil and gas sector spans close to a decade. Its first engagement was the provision of Environmental and Social Impact Assessment (ESIA) services for Exploratory drilling activities in Exploration Area 4B (the current Ngaji Block), to Dominion Uganda, its operators at the time.

The perception then, was that such a service was best entrusted with international environmental consultancy firms, as the national capacity to undertake such work was deemed to be close to zero! Fueled by a determination to correct what was in fact a misconception, Atacama was able to take advantage of the opportunity and exceeded all expectations. The rest, as they say, is history.

Atacama's execution of the Dominion engagement has since paved the way for numerous assignments in the sector for all the key players including: Total E&P, Tullow and CNOOC. The services have included ESIAs, Environmental monitoring and audits, waste management specialist studies, and social & resettlement services. In the case of the latter, Atacama is the lead contractor for the Tilenga project that is spearheaded by Total E&P and Tullow. The project will lay the foundations for the commercialisation of Uganda's oil reserves.

## Benefits of Participation in the Oil and Gas Sector

Nevertheless, the oil & gas sector calls for very high standards of its suppliers. It is therefore critical that potential players in the sector put in place the requisite management systems that satisfy all standards and requirements. An example of such a system is an integrated management system that encompasses quality, as well as environmental, health and safety aspects.

Partnerships are another factor to consider, as they are key in the mobilisation of resources; both human and financial. In the case of the latter, it's important to have good lines of credit from a lending institution or a partner that is financially sound.

Considering the dynamic nature of the sector, continuous professional development is also critical. Players must keep abreast with changes and innovations in the sector, and should ideally strive to be ahead of the curve. Anything short of that will soon put them on the path to being obsolete.

Needless to say, consistently high quality work lies at the heart of remaining relevant in the sector. A job well done will lead to more referrals for your services. There are no short-cuts when it comes to delivering good quality work in the oil & gas sector.
